Summary and Description of Services:

Videography fee agreed to: \$_____ A minimum deposit of \$_____ (50%) is due at the signing of this agreement, and the remaining balance is to be paid by date of the wedding.

ENTIRE AGREEMENT: This agreement contains the entire understanding between -VIDEOGRAPHER- and

the -CLIENT-. It supersedes all prior and simultaneous agreements between the parties. The only way to add or change this agreement is to do so in writing, signed by all the parties. If the parties choose to waive one provision of this agreement, it does not change any other provision. Any waivers made at the time of the signing, or agreed to prior, are to be notated on the original contract.

SERVICES RESERVATION:

A complete, signed contract (by both parties), as well as the minimum deposit payment are required to reserve the date and time of the camera coverage. **STYLE SPECIFICS:** It is up to the CLIENT to specify the overall desired style to be done and communicate this with VIDEOGRAPHER.

It is agreed by both parties that the VIDEOGRAPHER shall attempt to emulate the agreed upon style. VIDEOGRAPHER agrees to use their skills, experience, and abilities to achieve a satisfactory result for the CLIENT. There is no guarantee that the final results will be exactly in line with the CLIENT's vision, and the CLIENT recognizes that videography is an art form both subjective and variable. It is recognized by both parties that good communication will help facilitate this and setting aside time at the ceremony/reception for posed/group shots will facilitate a well-rounded final product. The CLIENT understands that it is their responsibility to allow and schedule sufficient time for successful documentation of their event. Written timelines/notes ahead of time are helpful in sticking to a schedule and achieving a desirable result. CLIENT's initials acknowledge their understanding. X_____.

SHOOTING TIME / ADDITIONS: The videography schedule and selected method are agreed upon by both the CLIENT and VIDEOGRAPHER, and are designed to accomplish the stated goals and wishes of the CLIENT in a manner enjoyed by all parties. CLIENT and VIDEOGRAPHER agree that punctuality is essential to that purpose. Shooting commences at the scheduled start time. Additional time MAY be available; however, the CLIENT should not expect it with certainty. Any additional shooting time, services, or products should be expected to entail additional costs.

HOUSE RULES: The VIDEOGRAPHER is limited by any guidelines, or house rules, of a ceremony official (if applicable) or site management. The VIDEOGRAPHER will abide by these limitations. It is agreed that the CLIENT is responsible for ensuring that these limitations are communicated to the

VIDEOGRAPHER in advance of the date of coverage (the earlier the better), and agrees to accept the technical results of these limitations on the VIDEOGRAPHER. Such negative effects can be but are not limited to: grainier images, limited takes, limited composition, and similar. Negotiation with the officials for moderation of guidelines is CLIENT's responsibility; VIDEOGRAPHER will offer technical recommendations only.

COPYRIGHT: The video(s) produced by VIDEOGRAPHER is protected by Federal Copyright Law (all rights reserved) and may not be reproduced in any manner without VIDEOGRAPHER's explicitly written permission.

EXHIBITION: CLIENT grants VIDEOGRAPHER permission to display selected takes resulting from this assignment as an example of VIDEOGRAPHER's work and for entrance into film and video competitions and publication, and release all claims to profits, or direct profits that may arise from the use of images. It is the standard policy of VIDEOGRAPHER to never use such images in a negative manner and should a specific image or the use of such an image be objectionable to the CLIENT, VIDEOGRAPHER Policy is to discontinue use of such an image as soon as is practical.

MODEL RELEASE: The CLIENT hereby grants and assigns to VIDEOGRAPHER and its legal representatives the irrevocable and unrestricted right to use and publish videos of the CLIENT or in which the CLIENT may be included, for editorial, trade, advertising and any other purpose and in any manner and medium; to alter the same without restriction. The CLIENT hereby releases VIDEOGRAPHER and its legal representatives and assigns from any and all claims and liability relating to said videos. The CLIENT agrees that the client's guests, spouse, family members, and attendees of the event shall be made aware of the videography taking place at this event and that they may at any time become subjects of the video(s). It is the CLIENT's responsibility to inform attendees of this.

LIMIT OF LIABILITY: In the unlikely event that the VIDEOGRAPHER is unable to work the event, for any reason beyond his control, VIDEOGRAPHER will make every reasonable effort to secure areplacement videographer. If a suitable replacement is not found, responsibility and liability is limited to the return of all payments received for the videography fee.

VIDEOGRAPHER takes great care with respect to the exposure, storage, processing and delivery of the images. If, in the unlikely event footage is lost, destroyed, or stolen for reasons within or beyond VIDEOGRAPHER's control, VIDEOGRAPHER liability is limited to the return of all payments received for the event package. The limit of liability for a partial loss of originals shall be a prorated amount of the exposures lost based on the percentage of total number of originals. **SECURITY DEPOSITS:** In the event of cancellation by the CLIENT, the security deposit paid of 50% is non-refundable. Damages shall be liquidated to VIDEOGRAPHER in the event of a breach of contract by CLIENT. The CLIENT shall additionally be responsible for payment for any VIDEOGRAPHER costs incurred up to the time of cancellation. This can be up to the complete amount of the agreed upon videography fee.

COMPLETION SCHEDULE: Videography processing takes approximately 90 days and should be ready for viewing no later than 120 days assuming the event takes place at the scheduled date and time.

PAYMENT SCHEDULE: Minimum deposit is due at signing. Full balance is due by the day of the wedding, prior to start of filming. Payment forms accepted at time of filming are cash, money order, direct deposit, Venmo and ATH Móvil. All other forms of payment must be cleared before the scheduled coverage begins.
